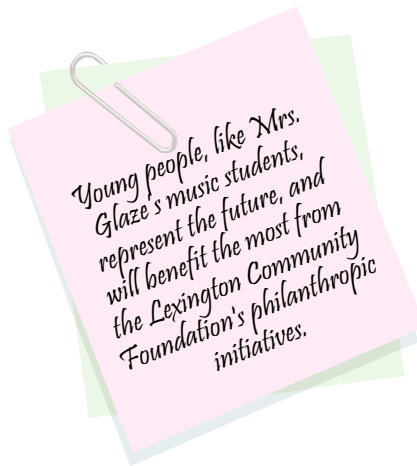
Dear Friends:

❖ THE FOUNDATION ADVISORY BOARD ❖

The Lexington Community Foundation (LCF) is governed by a 25-member volunteer Board of Directors. In addition to the acting Board of Directors, the by-laws of the Foundation allow for the creation of an Advisory Board “. . . whose members shall be chosen by the Board of Directors from persons who have previously been members of the Board of Directors.” At the Annual Meeting in July 2005, LCF board members voted to approve a seven-member Advisory Board.

The Advisory board members receive periodic financial reports and minutes of the Foundation. They are invited to attend our annual meeting each July, and have implemented the Advisory Board Fall Luncheon which for the past three years has been held in November.

Because each of these Advisory Board members have participated on the acting LCF board, they know how the Foundation operates and they have the understanding of our mission and goals. We look to these individuals for their expertise, opinions and ideas for the future. Their continued work with the Foundation is appreciated.

- ◆ The Lexington Community Foundation celebrated its 25th Anniversary of serving the Lexington community;
- ◆ Of the 41 funds administered by the Foundation, nine were new to the Foundation in 2007;
- ◆ \$825,627 were disbursed in the form of grants, scholarships and program support;
- ◆ LCF administered 89 scholarship awards totaling \$84,700;
- ◆ LCF Development Committee initiated meetings to discuss the possibility of a YMCA/Community Center in Lexington.

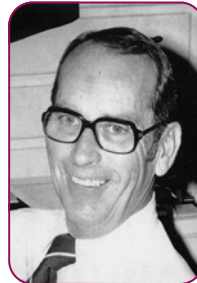

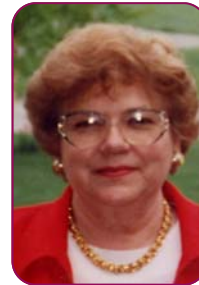
